CHILD DROP-OFF / PICK-UP POLICY

When you enroll your child in Tiger Kid's Club, it is to be understood our policy is for you to bring your child into the center each morning, sign the attendance sheet, and let a staff member know your child has arrived. Please note, we are not legally responsible for your child when she/he is dropped off outside the building.

As a parent or guardian, I am aware the Tiger Kid's Club staff is not responsible for my child unless I bring my child into the building and sign the attendance sheet and inform staff of my child's arrival.

I understand state law requires me to sign my child in and out each day. I also understand state law requires that I inform staff that my child is leaving.

POLICY AGREEMENT

I understand that I will be billed monthly.

I understand there is tuition of \$6.00 per day AM and \$7.00 per day PM. Students in the morning will be provided breakfast and students in the afternoon will be provided with a snack.

I understand that late fees (\$1.00 per minute) will be imposed if my child is picked up after Tiger Kid's Club designated closing time: **6:00 PM**.

I understand that I will sign my child "in"/"out" everyday.

I understand that the following steps will be taken when a child is left at the site past closing time:

- All emergency contacts on the child's enrollment form will be called until 6:45PM
- The police will be notified that the child has not been picked up, so they can assist in finding parents.

I understand that all forms in this registration packet must be completely filled out and turned in prior to my child's admission into the program.

I understand that I am required to disclose all medical, physical or behavioral issues at the time of my child's enrollment and supplement such information on an ongoing basis.

I understand that I forfeit the privilege of participating in the program if all policies are not followed.

I understand that parents will be held financially liable for property damage caused by their children. This includes, but is not limited to any property owned or possessed by the Huron City Schools and any personal property of others.

***I understand Tiger Kid's Club will not be offered when school is not in session.**
