

WRITTEN EDUCATION PLANS

Any student in the Huron City School district that receives services as designated in the *Operating Standards for Identifying and Serving Gifted Students* will have a current Written Education Plan. All Gifted Services shall be based on the students' area(s) of identification and individual needs guided by the WEP. Each WEP will contain:

- A. Description of services to be provided
- B. Goals for the students for each service to be provided
- C. Methods for evaluating progress toward goals specified
- D. Staff responsible for ensuring delivery of each service prescribed
- E. Policies regarding waiver of assignments and re-scheduling of tests (if applicable).
- F. Deadline for next review of WEP: Huron City Schools will review each WEP at the semester and/or on an as needed basis to assure that progress is being made.
- G. A copy of WEP will be issued to parents and all staff responsible for providing service listed. A copy will also be placed in the student's file.
- H. Huron City Schools will provide progress reports quarterly for those students served regarding the effectiveness of the services provided in accordance with the gifted student's WEP.

SERVICES PROVIDED FOR STUDENTS IDENTIFIED AS GIFTED

- A. Kindergarten through Grade 2 students identified as gifted are provided differentiated and enrichment activities through the regular classroom teacher with support by the gifted intervention specialist.
- B. Students identified as gifted in superior cognitive and/or reading in Grades 3 through 6 are provided services by the Gifted Intervention Specialist as the teacher of record for language arts instruction.
- C. Third and fourth grade students identified as gifted in mathematics are provided a combination third and fourth grade mathematics with the gifted intervention specialist as the teacher of record. Fifth grade students identified as gifted in mathematics are provided a gifted mathematics class. In addition, those who meet a two-prong eligibility assessment, qualify for acceleration beginning at Grade 6 through high school [end of the year screener and 95+ percentile on Iowa Test of Basic Skills].
- D. The High School offers advanced and honors level classes as well as allowing students to seek dual enrollment in PSEO and credit flexibility.
- E. According to the Ohio Administrative Code 3301-51-15, "a student shall be identified as exhibiting 'specific academic ability' superior to that of children of similar age in a specific academic ability field, if, within the preceding twenty-four months the child performs at or above the ninety-fifth percentile at the national level on an approved individual or group standardized achievement test of specific academic ability in that field." The "twenty-four months" is from the prior identification.

IDENTIFICATION OVERVIEW

Screening and Assessment Process for Superior Cognitive, Specific Academic, Creative Thinking, and Visual or Performing Arts Ability

The district uses a three-part approach to screen / assess students who perform or show the potential for performing at high levels of accomplishment:

- A. Pre-Assessment: All students are involved. Using this process the district ensures equal access to screening and further assessment by all district children regardless of culture, socioeconomic backgrounds, disabilities and children whom English is a second language.
- B. Assessment for Screening: At this stage it is determined if additional assessment is needed. If a student scores at or above the cut-off scores as determined in the *Assessment Instruments Used for Gifted Identification* students move to the assessment stage. Parents are notified within 30 days of the results of screening.
- C. Assessment for Identification: Strategies for Assessment include individual and group testing requirements as outlined in the *Operating Standards for Identifying and Serving Gifted Students*.

Huron City School District Testing Opportunities

- A. Fall: Based on recommendation from parents, teachers, or students.
- B. Spring: Based on recommendations stated above.
- C. All second and fourth graders are screened.

Testing Overview

- A. All assessments used have been approved by the Ohio Department of Education and are listed on the *Chart of Approved Gifted Identification/ Screening Instruments*.
- B. All testing in Huron City Schools will be administered by qualified personnel who include: trained class room teachers (group testing), gifted coordinator and school psychologist (individual testing) and trained test administrators.
- C. Parents are notified within 30 days of test completion of testing results. A letter will be sent home indicating whether the child qualified for gifted or whether more testing is needed.

Transfer Students and Appeals Process

- A. Huron City Schools insures that any child transferring into the district will be assessed within 90 days of the transfer at the request of the parent.
- B. If the student was previously identified, Huron City Schools accepts the scores provided by other districts and/or trained personnel outside the school district if the assessment instrument is on the approved Ohio Department of Education list.
- C. An appeal by a parent is the reconsideration of the results of any part of the identification process. If parents would like to appeal, they should submit a letter to the superintendent or the coordinator of gifted services outlining the nature of the concern. A meeting with the parent/guardian will convene and a final written decision with reasons for the decision will be issued within 30 days of the appeal.

TYPES OF GIFTED IDENTIFICATION

Types of Gifted Identification that could qualify a Student for Services

- A. **Superior cognitive ability:** The child scored two standard deviations above the mean, minus the standard error of measurement, on an approved individual standardized intelligence test administered by a licensed or certified school psychologist or licensed psychologist, on an approved standardized group intelligence test or performed at or above the ninety-fifth percentile on an approved individual or group standardized basic or composite battery of a nationally-normed achievement test.
- B. **Specific academic ability:** The child performs at or above the ninety-fifth percentile at the national level on an approved individual or group standardized achievement test of specific academic ability in that field. A child may be identified as gifted in more than one specific academic ability field.
- C. **Creative thinking ability:** The child scored one standard deviation above the mean, minus the standard error of measurement, on an approved individual or group intelligence test and also did either of the following:
 1. Attained a sufficient score, as established by the department of education, on an approved individual or group test of creative ability; or
 2. Exhibited sufficient performance, as established by the department of education, on an approved checklist by a trained individual of creative behaviors.
- D. **Visual or performing arts ability:** The child demonstrated to a trained individual through a display of work, an audition, or other performance or exhibition, superior ability in a visual or performing arts area; and exhibited to a trained individual sufficient performance, as established by the department of education, on an approved checklist of behaviors related to a specific arts area.

Withdraw From Gifted Programs or Services

- A. The request for withdrawal should be written by the parent to the building administrator if it is felt that the setting or services are not appropriate or beneficial to the student.
- B. A withdrawal form will be filed at the parent's request.
- C. Withdrawal will be reviewed yearly at students Written Education Plan meeting. Student will remain on roster of students identified as gifted.
